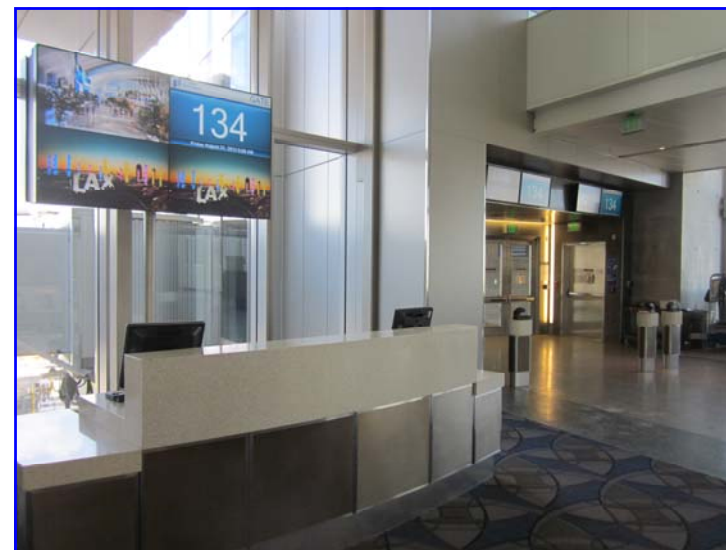

In order to begin operations in the new Bradley West facility, **every airline is required to conduct testing of the Common Use Terminal Equipment (CUTE) workstations at every gate.** To properly test the CUTE workstations, SITA and LAWA IT have recommended that every airline create a 'dummy' flight to confirm, prior to the beginning of operations at each gate, that systems can be accessed and boarding passes can be processed. The CUTE testing includes the following devices:

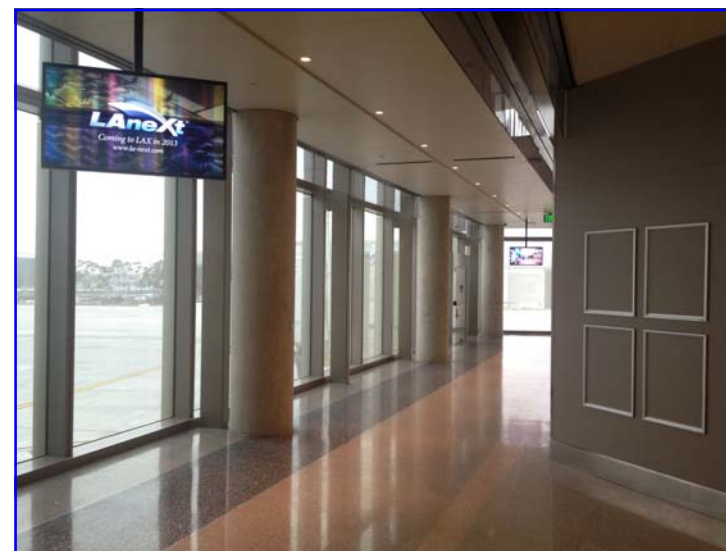
- Workstations
- Boarding Pass Printers
- Document Printer
- Boarding Gate Readers
- Telephones
- Paging System



In addition to the CUTE testing, the Electronic Visual Information Display System (EVIDS) has new features that need to be reviewed and understood by each of the TBIT airlines. EVIDS training for these systems is also required by LAWA Operations and include:

- Monitors Behind Gate Podium
- Monitors at Gate Pier Entrance
- Monitors in Gate Pier

Once each TBIT airline has completed the testing/training and have an understanding of the full capability of these new feature it should vastly improve the boarding process and passenger experience in the new facility.



Successful completion of CUTE testing and EVIDS training is necessary to prepare the TBIT airlines for operations in the new facility. **LAWA Operations will not assign an airline to a new gate until these items have been signed off by SITA and LAWA IT.** The spreadsheet to the left depicts TBIT airlines operational readiness for Gates 130, 132 & 134 as it relates to CUTE testing and overall EVIDS training as of 01 February 2013.

In addition to the CUTE testing and EVIDS training, the TBIT airlines also need to complete Passenger Boarding Bridge (PBB) training. TBITEC has developed a PBB Trainer Training Program and a PBB Operator Training Program to ensure only qualified trainers and operators are authorized to operate a PBB in the Bradley West facility. TBITEC performs the operator trainer training and it is the responsibility of each airline and/or service provider to perform the operator training. This process has been established to help ensure safe and secure operations. It is up to each airline to make sure that there are enough trained operators within their airline and/or service provider to support the operation. **LAWA Operations will not assign an airline to a new gate until TBITEC can verify that sufficient personnel have been trained to support the particular airline operation.**
